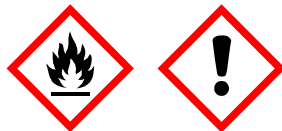

5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Cool closed containers exposed to fire with water. SECTION 11: Toxicological information

11.1 Information on toxicological effects

The product has been assessed following the conventional method and is classified for toxicological hazards accordingly.
